- Community

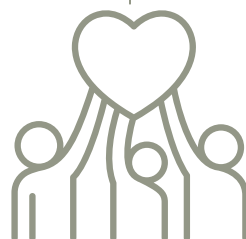


What a Board Member Does

Our Board of Directors is responsible for the care, control and governance of the organization. It is comprised of 10 elected Community Directors and 3 ex-officio members (who represent our healthcare partner agencies). Directors are elected at the annual general meeting of the Board held in June for a term of 2 years, with service of up to 8 years.

Our Board of Directors:

- Determines the organization's overall strategic direction and monitors performance.
- Reviews and provides financial oversight and ensures the wise use of resources.
- Steers the Foundation towards its vision in accordance with its values and legal and ethical standards.
- Serves on committees and acts as an ambassador for the Foundation and its Healthcare Partners.
